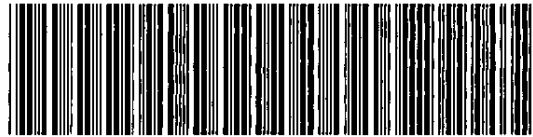

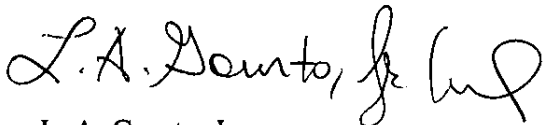

NAME

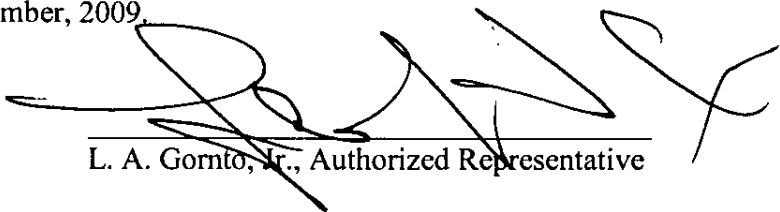

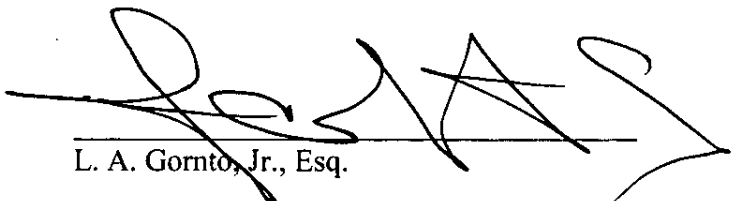
