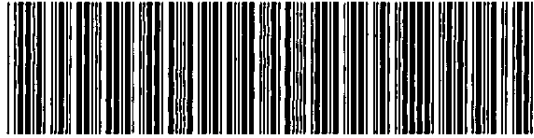

The name of the limited liability company is TM Patterson, LLC that is located at 9220 Grand Palm Court, Riverview, FL 33578-3045.


