The mailing address and street address of the principal office of the company shall be 405 26th Ave. W., Bradenton, FL 34205.





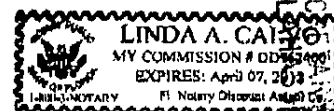
