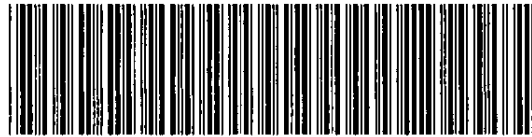

The undersigned being a Member of American Surgery Center, LLC, a Florida limited liability company (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amends the Articles of Organization of the Company as set forth below:

1. The name of the Company is AMERICAN SURGERY CENTER, LLC.
2. The Articles of Organization for the Company were filed with the Florida Department of State effective September 14, 2009.
3. Article I of the Articles of Organization of the Company is hereby amended in its entirety to read as follows:

"ARTICLE I.
NAME

"The name of the Limited Liability Company shall be AMERICAN SURGERY CENTERS, LLC."

4. This Amendment shall be effective upon filing with the Florida Department of State.
5. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
