3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.


4. Place of Business. The mailing address and street address of the Company's principal office is 3221 North Service Road, Ste. 200, Burlington, Ontario.


