The undersigned, as Members of Achton Group Managers, L.L.C., a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), state as follows:

1. The current name of the Company is ACHTON GROUP MANAGERS, L.L.C.
2. The date of the filing of the original Articles of Organization of the Company was September 17, 2009.
3. The Articles of Organization of the Company are hereby amended by deleting Article I entitled "Name" in its entirety and inserting the following section in its place and stead:

ARTICLE I - NAME

The name of the limited liability company is ACTON GROUP MANAGERS, L.L.C. (the "Company").

4. The Articles of Organization of the Company are hereby amended by deleting Article II entitled "Address" in its entirety and inserting the following section in its place and stead:

ARTICLE II - ADDRESS

5. The Articles of Organization of the Company are amended by deleting Article IV entitled "Management" in its entirety and inserting the following section in its place and stead:
