<u>ARTICLES OF ORGANIZATION</u> <u>OF</u> <u>ASHLAND PRODUCTS, L.L.C.</u>

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608 Florida Statutes, hereby make, acknowledge and file the following Articles of Organization.

ARTICLE I - NAME
