*Pursuant to the provisions of section 608.411, Florida Statutes, SHG OYSTER, LLC adopts the following amendment to its Articles of Organization:*

**FIRST:** The Articles of Organization of SHG OYSTER, LLC, a Florida limited liability company (the "Company"), were filed on September 21, 2009 and assigned Document Number L09000090963.
