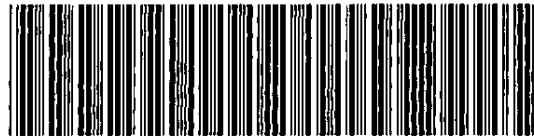

**ARTICLE 1 - NAME**

The name of the professional limited liability company shall be Corless Zinober, PLC

**ARTICLE 2 - ADDRESS**

The mailing address and street address of the principal office of the company is 1300 N. Westshore Blvd., Suite 215, Tampa, Florida 33607.

**ARTICLE 3 -DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on September 1, 2009. The company's existence shall be perpetual or shall terminate or be dissolved earlier as provided in these articles of organization or in the regulations.

**ARTICLE 4 -REGISTERED OFFICE AND AGENT**

**ARTICLE 5 -CAPITAL CONTRIBUTIONS**


ARTICLE 8 - MEMBERS' RIGHT TO CONTINUE BUSINESS


