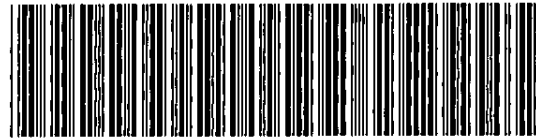

6. The conversion was effective under the laws of Delaware on 08/24/11.


7. The conversion shall become effective in Florida on 08/24/11.
