DURATION**

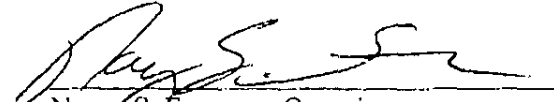

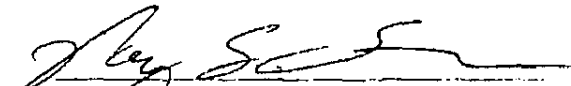
