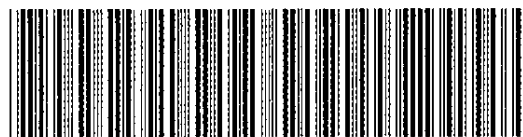

ARTICLES OF ORGANIZATION

ARTICLE VII - AMENDMENT




