ARTICLES OF ORGANIZATION

OF

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

ARTICLE I

Name

The name of the Limited Liability Company is: **ML PARKER, LLC**

ARTICLE II

Address of Place of Business

ARTICLE III

Purpose

The Limited Liability Company is organized for the purpose of transacting any and all law business for which limited liability companies may be formed under Chapter 608 of the Florida Statutes. Management




