

Articles of Organization
of

Pursuant to the provisions of Section 608.407, Florida Statutes, the undersigned hereby declares the following provisions as the Articles of Organization of Krystel Clear Properties, L.L.C., a Florida limited liability company (the "Company"):


1. **Name**. The name of the Company is **Krystel Clear Properties, L.L.C.**
2. **Duration**. The Company shall exist perpetually.
3. **Purpose**. The company is organized to engage in and to do any lawful act concerning any and all lawful business, other than banking or insurance, for which a limited liability company may be organized.
4. **Principal Office**. The mailing address and street address of the initial principal office is as follows: 8381 Seminole Boulevard, Seminole FL 34642.
5. **Registered Agent**. The name of the initial registered agent is Maury H. Krystel, whose business address is the same as that of the principal office.
6. **Management; Initial Members**. The Company is to be managed by one or more Managers and is, therefore, a manager-managed company. The number of Managers may either be increased or decreased from time to time by agreement of the Members but shall never be less than one. The name of the initial Manager is Maury H. Krystel.
7. **Written Operating Agreement**. Any operating agreement must be in writing.
8. **Effective Date**. These Articles shall be effective as of the date of filing.
