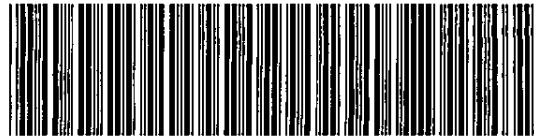

ARTICLE I--NAME

The name of this limited liability company is P. H. JOHNSON FAMILY, L.L.C.

ARTICLE II--PURPOSE
