The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **9464 NW 52 DORAL, LLC**, a **Florida limited liability company** (the "Company").

**ARTICLE II -- ADDRESS**




**ARTICLE X -- INDEMNIFICATION**
