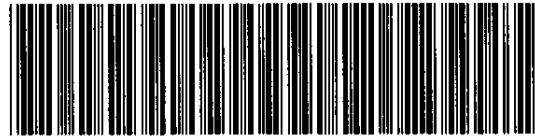

FIRST: The name and address of this Company is **INTERNET MARKETING TECH GROUP LLC**, 3206 Cleopatra Court, Saint Cloud, Florida 34771.

SECOND: The date of the adoption of these Articles of Dissolution is 19 October 2009.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members.
