ARTISAN OPERATIONS, LLC**

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, the purpose of forming a limited liability company under the laws of the State of Florida sets forth the following:

ARTICLE I: NAME

The Name of the Limited Liability Company is: Artisan Operations, LLC
