The undersigned hereby certifies that it has formed a limited liability company under the State of Florida.

#### ARTICLE I Name

## ARTICLE VII Management

The management of the limited liability company shall be vested in the Member. The Member shall have the powers granted to him in the Operating Agreement, if such agreement is adopted by the Company or as otherwise available under the laws of the State of Florida.
