

The undersigned, desiring to form a limited liability company under and pursuant to Florida Statutes Chapter 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company:

<u>ARTICLE I – NAME</u>

The name of this Company shall be ANGEL HAIR SALON & SPA, L.L.C.

<u>ARTICLE II – PURPOSE</u>

This Company is formed to own and operate a hair and nail salon, and to provide all manner of services in connection therewith. In addition, the Company shall be authorized to undertake any lawful business or enterprise allowed by the Laws of the State of Florida and of the United States.

<u>ARTICLE VII – RIGHT TO CONTINUE BUSINESS</u>
