The Company shall be managed by the Manager(s) of the Company as provided in the Company's Operating Agreement.

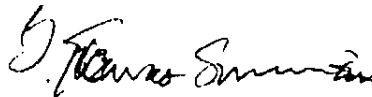
The initial Manager of the Company is G. Thomas Simmons, who shall serve until replaced according to the provisions of the Company's Operating Agreement.
