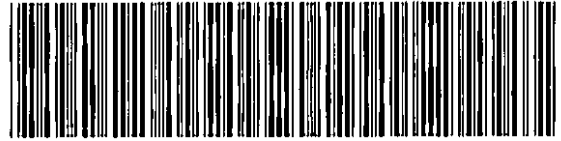

The Articles of Organization for this Company were filed on October 5, 2009 and assigned  
Florida document number L09000095793.

This First Amendment amends the original Articles as follows:

1. **Article 4, on page 2 of 3,** of the original Articles is amended to reflect the change in the Company's membership of Steven E. Allen to be Steven E. Allen and Elizabeth B. Allen. Tenants by the Entirety, and the percentage of ownership of 40% is changed to 15%.
2. **Article 4, on page 2 of 3,** of the original Articles is amended to reflect the change in the Company's membership as a result of the death of William J. Roberts on June 15, 2012. The successor to that 10% membership is Owen Goodwyne, Trustee of the William J. Roberts Family Trust, a Testamentary Trust with effective of June 15, 2012.
3. **Article 4, on page 2 of 3,** of the original Articles is amended to reflect an additional member who is Alan W. Niedoroda and Betty W. Niedoroda as Co-Trustees of the Niedoroda Family Trust under Agreement dated June 18, 2018 and the percentage of ownership is 25%.
