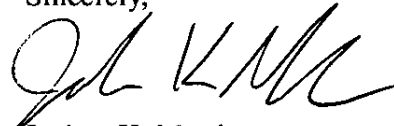

**ARTICLES OF ORGANIZATION OF
LAW OFFICE OF JOSHUA K. MARTIN, P.L.**

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I. NAME

The name of the limited liability company shall be **Law Office of Joshua K. Martin, P.L.**

ARTICLE II. ADDRESS

The mailing address and principal office of the limited liability company shall be at **308½ Centre Street in the City of Fernandina Beach, County of Nassau, State of Florida, zip code 32034**, but the limited liability company shall have the power and authority to establish branch offices at any other place or places as the members may designate.

ARTICLE III. REGISTERED OFFICE AND REGISTERED AGENT

The address of the registered office of the limited liability company is **308½ Centre Street, City of Fernandina Beach, County of Nassau, State of Florida, zip code 32034**, and the name of the company's initial registered agents at that address is **Joshua Martin**.

ARTICLE IV. MANAGEMENT

Management of this limited liability company is reserved to its members, whose names and addresses are as follows:

ARTICLE V. PURPOSES AND POWERS

This limited liability company is organized for the following purposes:

- (a) To engage in the practice of law as a professional limited liability company and carry on services incident to the practice of law. The practice of law is the sole and exclusive professional service to be rendered by this limited liability company.
- (b) To own property, enter into contracts, and to carry on any business necessary or incidental to the accomplishment or furtherance of the purposes or objects of this limited liability company.

The professional services of this limited liability company shall be carried out only through officers, employees, and agents, each of whom has been admitted to the bar of, and is duly authorized to practice law in, the State of Florida.

ARTICLE VI. EXERCISE OF POWERS

All limited liability company powers shall be exercised by or under the authority of, and the business and affairs of this limited liability company shall be managed under the direction of, the members of this limited liability company. This Article may be amended from time to time in the regulations of the limited liability company by a unanimous vote of the members of the limited liability company.

ARTICLE VII. MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. All new members must be licensed to practice law in Florida. Contributions required of new members shall be determined as of the time of admission to the limited liability company.

A member's interest in the limited liability company may not be sold or otherwise transferred except with the written consent of all members.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE VIII. CAPITAL CONTRIBUTIONS

Capital contributions in the amount of \$1000.00 cash shall be paid to the limited liability company by the one member. Additional contributions will be made as required for investment purposes, as determined by unanimous consent of the members. Members will make contributions in equal shares.

ARTICLE IX. PROFITS AND LOSSES

(a) *Profit Sharing.* The members shall be entitled to the net profits arising from the operation of the limited liability company business that remain after the payment of the expenses of conducting the business of the limited liability company. Each member shall be entitled to an equal distributive share of the profits. The distributive share of the profits shall be determined and paid to the members each year on the anniversary date of the commencement of business of the limited liability company, the month and day of the commencement date being October 1, 2009.

(b) *Losses.* All losses that occur in the operation of the limited liability company business shall be paid out of the capital of the limited liability company and the profits of the business, or, if

these sources are insufficient to cover such losses, by the members in equal shares.

ARTICLE X. EFFECTIVE DATE AND DURATION

These Articles shall be effective beginning **October 5, 2009**.

This limited liability company shall exist until August 1, 2011, or until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.
