**ARTICLES OF ORGANIZATION

The undersigned, pursuant to the provisions of Chapter 608 of the *Florida Statutes*, for the purpose of forming a Limited Liability Company under the laws of the State of Florida do set forth the following:

1. **NAME.**

The name of the Limited Liability Company is: **Suddath Painting, LLC.**

2. **ADDRESS.**
