MANAGEMENT**

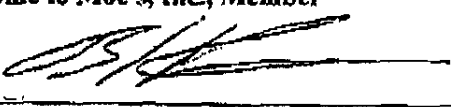
The Company is to be managed under the direction of a Management Committee and is, therefore, a manager-managed company.

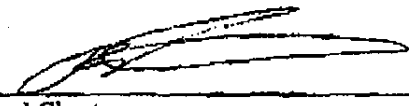
