#### ARTICLE I

Name. The name of the limited liability company ("Company") is Caricom Supplies, LLC.

#### ARTICLE II

#### ARTICLE VII

Admission of New Members. The Manager of the Company has the right to admit new members. Operating Agreement. The Operating Agreement of the Company shall be made, alford or rescinded by a majority vote of the Members of the Company at a meeting of the Members; alternatively, all of the Members may sign a written statement adopting the proposed Operating Agreement or changes thereto.

#### ARTICLE XI

<u>Preemptive Rights.</u> The Members of the Company shall have preemptive rights to purchase, at prices, terms and conditions that shall be fixed by the Members, such membership interests as may be issued for money, or any property or services from time to time, in addition to the present memberships. The preemptive right of any Member is determined by the ratio of the membership interest held by a Member to all membership interests currently outstanding.
