AMENDED AND RESTATED ARTICLES OF ORGANIZATION

OF

MILE MARKER BREWING LLC

The undersigned, for the purpose of amending and restating the Articles of Organization of MILE MARKER BREWING LLC, a Limited Liability Company formed under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Amended and Restated Articles of Organization.

<u>ARTICLE 1 – NAME</u>

The name of the Limited Liability Company shall be MILE MARKER BREWING LLC.

ARTICLE 2 – ADDRESS

The principal place of business of the Limited Liability Company in Florida shall be 3420 Agriculture Center Drive, Saint Augustine, Florida 32092; and the mailing address shall be 14 Farmstead Lane, Wayne, New Jersey 07470.

ARTICLE 3 – EFFECTIVE DATE

These Amended and Restated Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4 – DURATION

Subject to the provisions of Article 8, the Company's existence shall terminate no later than 99 years from the date of its commencement, unless the Company is earlier dissolved as provided in these Amended and Restated Articles of Organization.

ARTICLE 5 – PURPOSES AND POWERS

The general purpose for which the Limited Liability Company is organized is to engage in the business of beer manufacturing and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Limited Liability Company shall have all of the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGEN

The name and the Florida street address of the registered agent are:

Having been named as registered agent and to accept service of process for the above stated limited liability company at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in Florida Statutes Chapter 608.

ARTICLE 7 – ADMISSION OF NEW MEMBERS

No additional member(s) shall be admitted to the Limited Liability Company except with the written consent of a majority in interest of all Members. A Member may transfer his or her interest in the Limited Liability Company as set forth in the Operating Agreement of the Limited Liability Company, but the transferee shall have no right to participate in the management of the business and affairs of the Limited Liability Company or become a Member of the Limited Liability Company unless a majority in interest of the Members of the Limited Liability Company other than the Member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE 8 – TERMINATION OF EXISTENCE

The Limited Liability Company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a Member, or upon the occurrence of any other event that terminates the continued membership of a Member in the Limited Liability Company, unless the business of the Limited Liability Company is continued by the consent of a majority in interest of all Members, provided there is at least one remaining Member.

ARTICLE 9 – MANAGEMENT

The Limited Liability Company shall be managed by Managing Members in accordance with the Operating Agreement adopted by the Members for the management of the business and affairs of the Limited Liability Company. The Operating Agreement may contain any provision for the regulation and management of the affairs of the Limited Liability Company not inconsistent with law or these Amended and Restated Articles of Organization. Members may be elected as Managing Members by a majority in interest of all Members.
