The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **BARAKA GLOBAL INVESTMENTS, LLC, a Florida limited liability company** (the "Company").

ARTICLE V -- CAPITAL CONTRIBUTIONS



The Company shall indemnify each Member, Manager and Organizer of the Company in accordance with the Operating Agreement


