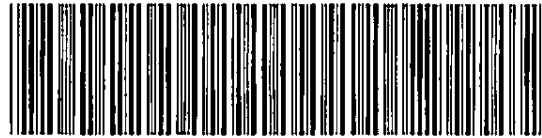

The mailing address and street address of the principal office of the Limited Liability Company is **590 Oak Street, Jacksonville, Florida 32204**.


**ARTICLE III**

**MEMBERS RIGHTS TO CONTINUE BUSINESS**


