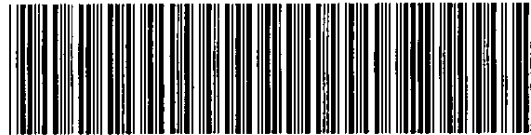

ARTICLE III PURPOSE

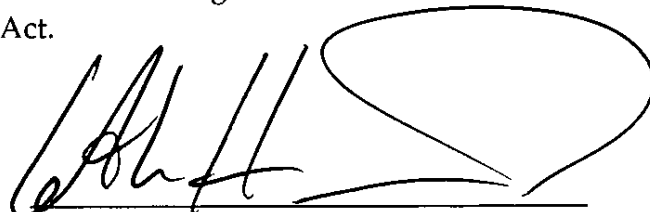

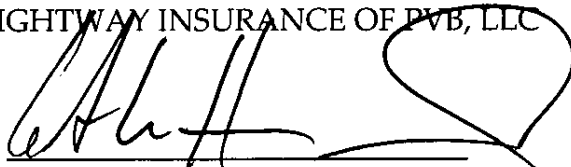

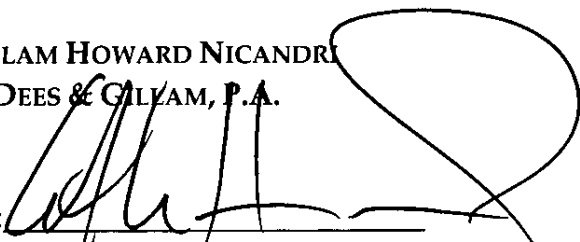
