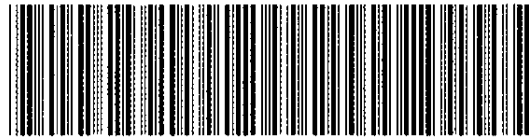

ARTICLE 9 - TERMINATION OF EXISTENCE

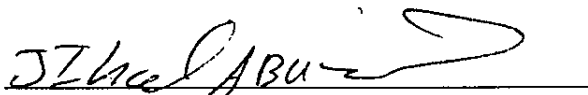
