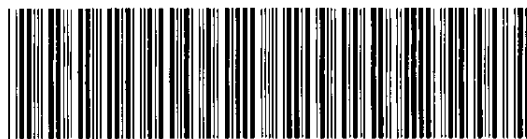

The name of the limited liability company is Network Consciousness Credit, LLC (the "Company").


**ARTICLE II


