SECOND: "Article II. Address" of the Company's Articles of Organization is hereby amended to read as follows:

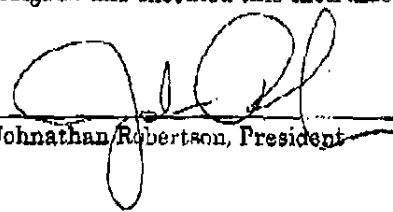
