The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE 1 - NAME**

The name of the limited liability company shall be **ADVANCED SURVEILLANCE LLC** ("Company").

#### **ARTICLE 5 - PURPOSES AND POWERS**

The general purpose for which the Company is organized is to engage in the business of electronic surveillance services and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. 


