## ARTICLES OF DISSOLUTION

- SECOND:** The Articles of Organization were filed on 16th day of October, 2009 and assigned document number L09000100025.
- THIRD:** The date of the adoption of these Articles of Dissolution is 5 March 2013.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421.
