AMENDMENT TO THE ARTICLES OF ORGANIZATIONOFBRADENTON PHYSICAL MEDICINE, LLC

The undersigned being the sole Member for BRADENTON PHYSICAL MEDICINE, LLC, a Limited Liability Company organized under the laws of the State of Florida, hereby certifies:

1. That the name of the Limited Liability Company is BRADENTON PHYSICAL MEDICINE, LLC. The Articles of Organization were filed with the Secretary of State of the State of Florida on October 16, 2009.

2. The Articles of Organization of said Company are amended as follows:


a. That the Articles of Organization are hereby amended to change the name of the Company to "INTEGRATED PHYSICAL MEDICINE, LLC," and the previous name of the Company shall be deleted from the Articles of Organization in each and every place where it appears and the new name substituted in place thereof. Said name change shall take effect immediately upon the filing of this Amendment to the Articles of Organization.

b. The Articles of Organization are hereby further amended by deleting ARTICLE III, Purpose, in its entirety and substituting in place and stead the following:

"The Company is created for the purposes of rendering healthcare services and to engage in any other lawful activity deemed appropriate by the Member from time to time."

3. In all other respects the Articles of Organization are ratified, reaffirmed and remain unchanged.

4. The above Amendment to the Articles of Organization of BRADENTON PHYSICAL MEDICINE, LLC. was adopted by the written consent of the sole Member of the Company on November 20, 2009, the same being sufficient to adopt the Amendment.
