**ARTICLES OF ORGANIZATION
OF

The undersigned hereby certifies that the Member has set forth the following for the purpose of becoming a Limited Liability Company under Florida Statutes Chapters 608, providing for the formation, rights, privileges, and immunities of limited liability companies for profit and the following Articles of Organization are hereby adopted.

**ARTICLE I.
NAME**

The name of the Limited Liability Company shall be THE LEAGUE OF TAMPA BAY, LLC.

**ARTICLE II.
DURATION; EFFECTIVE DATE**

This Limited Liability Company shall exist perpetually, commencing as of the date on which these Articles of Organization are filed with the Division of Corporations, State of Florida.

**ARTICLE III.
ADDRESS; PRINCIPAL OFFICE**

**ARTICLE IV.
INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

**ARTICLE V.
PURPOSE**

This Limited Liability Company may engage in any activity or business permitted under the laws of the state of Florida.

continue the business upon affirmative vote of a majority of the remaining Members who hold voting interests.

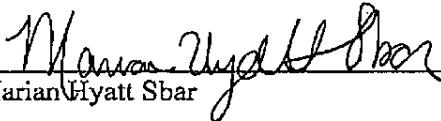
**ARTICLE VII.

These Articles of Organization will be effective as of that date of acceptance by the Division of Corporations, State of Florida.

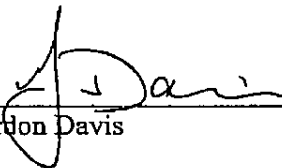
