ARTICLES OF ORGANIZATION OF RUSSELL TURNER'S FINE FURNITURE, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

Article 1 - Name
