**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF  
OCALA CONCRETE SERVICES, LLC**

The undersigned hereby executes and acknowledges these Amended and Restated Articles of Organization for the purpose of amending the Electronic Articles of Organization in accordance with the laws of the State of Florida.

**ARTICLE I  
NAME**

The name of this company is **OCALA CONCRETE SERVICES, LLC.**

**ARTICLE II  
PERIOD OF DURATION**

This company shall commence as of the date these Amended and Restated Articles of Organization are filed with the Department of State of the State of Florida and shall exist perpetually thereafter, unless this company is dissolved pursuant to the terms of the operating agreement for this company or by operation of law.

**ARTICLE III  
BUSINESS, OBJECTS OR PURPOSES**

The general nature of the business to be transacted by this company, or the objects or purposes of this company, shall be in general, to have and exercise all powers conferred by the laws of Florida upon limited liability companies, and to do any and all things hereinabove set forth to the same extent as a natural person might or could do.

**OPERATING AGREEMENT**

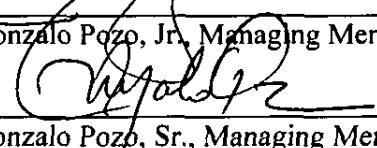

The Articles of Organization may be amended at any time by a majority vote of the members of the company.

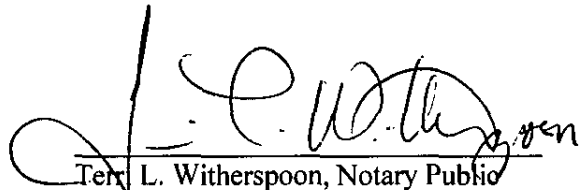

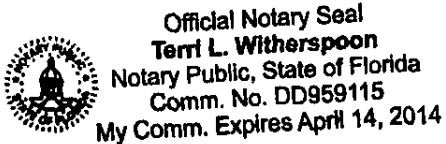
