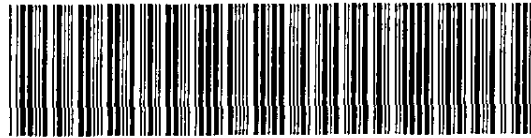

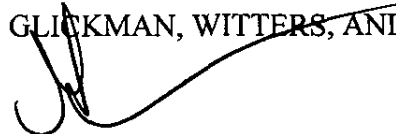

The name of this limited liability company is CD FAMILY HOLDINGS, LLC

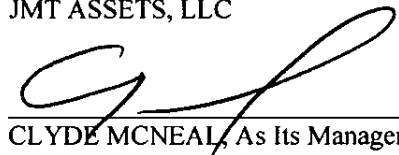

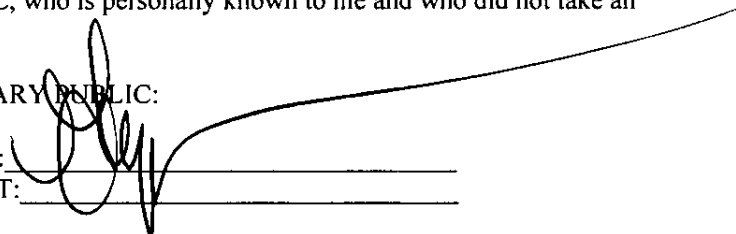
