JASBR, LLC, a Florida limited liability company, hereby amends its Articles of Organization and states as follows:

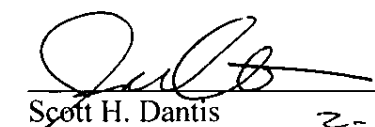
1. The name of the limited liability company is JASBR, LLC.
