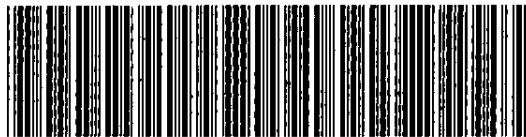

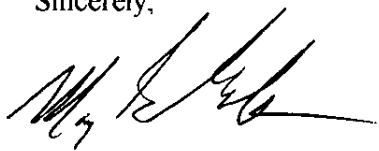

## **ARTICLES OF ORGANIZATION**

**OF**

**RWK, L.L.C.**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

### **ARTICLE I. NAME**

The name of the limited liability company shall be RWK,L.L.C.

### **ARTICLE II. ADDRESS**

### **ARTICLE III. DURATION**

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these articles or organization or in the regulations.

### **ARTICLE IV. REGISTERED OFFICE AND AGENT**

### **ARTICLE V. ADMISSION OF NEW MEMBERS**

The company shall be dissolved on the death, bankruptcy, or dissolution of a member, manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by unanimous vote

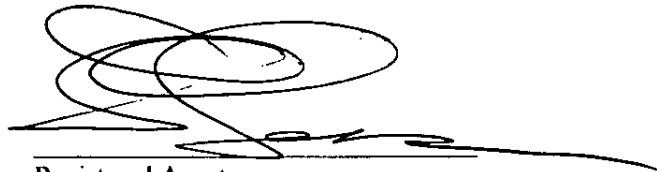
