

**ARTICLES OF ORGANIZATION**  
**OF**  
**LongBones, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I**  
Name and Principal Place of Business

The name of the limited liability company shall be **LongBones, LLC** (hereinafter the "Company"). The principal place of business and mailing address of the Company shall be 1318 Preakness Point, Tallahassee, Florida 32308.

**ARTICLE II**  
Duration

Registered Office and Agent


