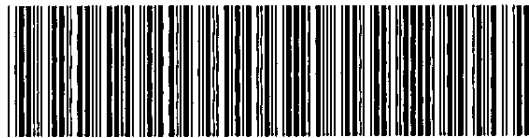

ARTICLE I
NAME






