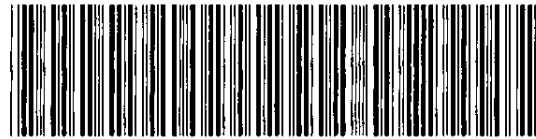

ADMISSION OF ADDITIONAL MEMBERS


