MANAGEMENT**

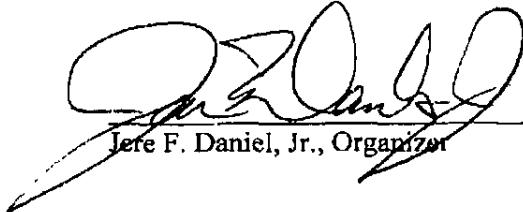

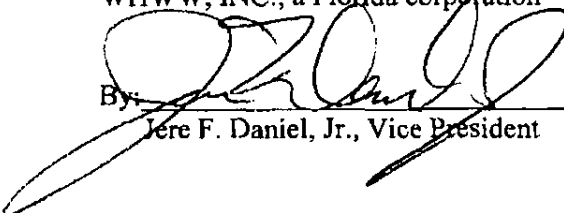
