The street address and the mailing address of the principal office of the Company is 2410 Boxwood Lane, Fernandina Beach, Florida 32034.


**ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS**


**CERTIFICATE OF DESIGNATION
