ARTICLES OF ORGANIZATION

OF

SPALDING DAY, LLC

(A Florida Limited Liability Company)

The undersigned organizer hereby adopts these Articles of Organization for the purpose of forming a Limited Liability Company under The Florida Limited Liability Company Act, Chapter 608 of the Florida Statutes (the "Act").

- 1. <u>NAME</u>. The name of this limited liability company (the "Company") is **SPALDING DAY, LLC.**
 - 2. **DURATION.** The period of duration of the Company shall be perpetual.
- 3. **PURPOSE**. The purpose and business of the Company shall be to engage in any lawful act or activity which may be carried on by a limited liability company under the Act.
- 4. MAILING ADDRESS AND STREET ADDRESS OF PRINCIPAL OFFICE. The mailing address and street address of the principal office of the Company is: 1303 Berkshire Court, Venice, Florida 34292.

- 6. MANAGEMENT. The name and address of the initial Member who shall manage the Company is TOM D. AIMAR, 1303 Berkshire Court, Venice, Florida 34292.
- 7. <u>ADDITIONAL MEMBERS</u>. New Members may be admitted only upon the unanimous written consent of the Members and in accordance with restrictions set forth in the Operating Agreement of the Company.
- 8. **LIMITED LIABILITY.** No Member or Manager or agent of the Company shall be liable under a judgment or decree, or order of a court, or in any other manner for any debt, obligation, or liability of the Company.
- 9. <u>CONTINUATION OF BUSINESS</u>. The remaining Members may, by manimous agreement, elect to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptey, or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company. No Member shall be entered

to receive a return of capital or other distribution upon withdrawal from this limited liability company or otherwise, except as otherwise provided in the Operating Agreement of the Company.
