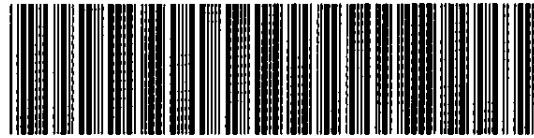

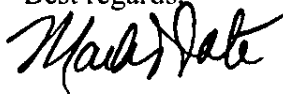

ARTICLES OF ORGANIZATION

OF

INNOVATIVE CONCEPT GROUP ALABAMA, LLC

I hereby file these Articles of Organization as the authorized representative of the member of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

ARTICLE I NAME

The name of the limited liability company to be formed hereunder is "INNOVATIVE CONCEPT GROUP ALAMABA, LLC" (the "Company").

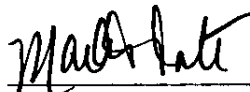
ARTICLE VII
