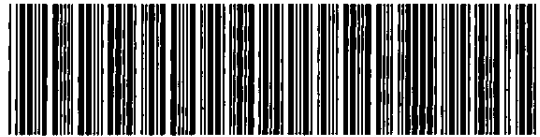

ARTICLE III – Purpose and Powers


